IMPORTANT INFORMATION ABOUT YOUR INSURANCE POLICY WITH USAA LIMITED – PLEASE READ CAREFULLY

Our records show that you currently hold or previously held an insurance policy or policies with USAA Limited (USAA LTD).

We are writing to you to inform you that it is proposed that on **31 December 2022**, USAA LTD will transfer all of its insurance business to USAA S.A. as follows:

- all of its general insurance business which relates (in whole or in part) to a risk or risks situated in the European Economic Area (**EEA**) will be transferred to USAA S.A., an insurance company based in the Grand-Duchy of Luxembourg; and
- all of its general insurance business which relates (in whole or in part) to a risk or risks situated in the United Kingdom (UK) will be transferred to the UK branch of USAA S.A (USAA S.A. UK Branch),

(together, the **Proposed Transfer**).

Your USAA LTD policy/policies will form part of the Proposed Transfer. Any policy/policies that you hold with USAA S.A or USAA S.A. UK Branch will not form part of the Proposed Transfer and will not be affected by it.

As of 1 January 2019, USAA LTD stopped offering new policies to policyholders based in the EEA. From this date, renewal of existing USAA LTD policies was undertaken by USAA S.A.

As of 1 April 2022, USAA LTD stopped offering new policies to policyholders based in the UK. From this date, renewal of existing USAA LTD policies has been undertaken by the USAA S.A. UK Branch.

The Proposed Transfer will therefore result in all policies that you took out with USAA Limited being provided by the same insurer, USAA S.A. (whether via its head office or USAA S.A. UK Branch).

This letter contains important information about the Proposed Transfer, to allow you reasonable time to consider whether you and/or your interested parties (e.g. other people insured under or beneficiaries of your policy/ies) may be adversely affected by the Proposed Transfer.



Background

The UK ceased to be a member of the European Union (the **EU**) on 31 January 2020 (**Brexit**). As a result of Brexit, it has been necessary for the USAA group to restructure its European operations and it now proposes to consolidate its insurance business into one European insurer (i.e. USAA S.A.). This should simplify the position for policyholders going forward.

Accordingly, under the Proposed Transfer, USAA LTD proposes to transfer: (a) its EEA insurance business to USAA S.A. and (b) its UK insurance business to USAA S.A. UK Branch.

Information about USAA S.A.

USAA S.A. is an insurance company incorporated in the Grand-Duchy of Luxembourg, authorised and regulated by the Commissariat aux Assurances (the **CAA**). USAA S.A. is a member of the USAA group, along with USAA LTD. The United Services Automobile Association, the ultimate parent of all companies in the USAA group, has a A++, AA+, Aaa financial strength rating from A.M. Best, Moody's and SPG Global respectively.

Information about USAA S.A. UK Branch

USAA S.A. UK Branch is a branch of USAA S.A. that was established in the UK on 1 May 2021. As well as being authorised and regulated by the CAA in the Grand-Duchy of Luxembourg, it is authorised by the Prudential Regulation Authority (the **PRA**) and the Financial Conduct Authority (the **FCA**) in the UK. USAA S.A. UK Branch, as part of USAA S.A., is part of the USAA group, along with USAA LTD.

Information about the Proposed Transfer

The Proposed Transfer must be carried out in accordance with the UK Financial Services and Markets Act 2000. This requires us to obtain approval from the High Court of England and Wales (the **Court**). An independent expert (the **Independent Expert**) has been appointed to write a report for the Court. The Independent Expert has assessed the impact of the Proposed Transfer and has concluded that it will not materially adversely affect any group of policyholders.

It is a legal requirement for us to contact you as part of this process, and should you consider that you are adversely affected by the Proposed Transfer, you are entitled to make representations to the Court. This letter contains information on how to do so.

Section 1.3 in the "Questions and Answers Booklet", referred to below, will assist you in identifying which policies will (in whole or in part) form part of the Proposed Transfer. If you remain unsure which of your policies will transfer to USAA S.A. and/or USAA S.A. UK Branch, please contact us using the details provided below.

If your policy or policies transfer(s) to USAA S.A. and/or USAA S.A. UK Branch under the Proposed Transfer, any renewals of such policy or policies which fall on or after **31 December 2022** will be undertaken by, and result in a contract with, USAA S.A. and/or USAA S.A. UK Branch (as the case may be) on the relevant renewal date.

Nothing in this letter should be deemed to be an acknowledgment or acceptance of the validity of any claim you may have made or may make in the future or of any liability of USAA LTD (or, following the Proposed Transfer, USAA S.A. and/or USAA S.A. UK Branch) in relation to any such claim (and, in particular, any

reservation of rights which if issued shall remain fully reserved) or the validity of your policy (including where such policy has been voided).

The Proposed Transfer will have no effect on:

- our obligations to you;
- the terms and conditions of your cover;
- the amount of your premium;
- the duration of your policy or policies;
- the way your policy is administered; or
- any claim which you may have made or may make under your policy or policies, including the way any claims you have made or may make under your policy or policies are handled.

However, your eligibility for access to the UK's Financial Ombudsman Service and the UK's Financial Services Compensation Scheme may change following the Proposed Transfer. Further information about this is set out in the "Questions and Answers Booklet" enclosed with this letter.

How are your interests being protected?

The legal approval process for the Proposed Transfer to USAA S.A. and USAA S.A. UK Branch is designed to help safeguard your interests.

The Court must approve the Proposed Transfer for it to go ahead. The Court will consider whether the Proposed Transfer will adversely affect policyholders and other interested persons and whether it is appropriate to approve the Proposed Transfer. The Court hearing is due to take place on **21 November 2022** at the **High Court of Justice**, **7 Rolls Building**, **Fetter Lane**, **London**, **EC4A 1NL**, **United Kingdom**. Any change to the date of the Court hearing or the date of the Proposed Transfer will be announced on our website (www.usaa.com/brexit).

You have the right to attend the Court hearing that will consider the Proposed Transfer and to present any objections or concerns that you may have directly, or appoint legal counsel to attend on your behalf. If you want to telephone or write to us rather than appear in person, we will present in writing any objections received from you to the Court on 21 November 2022. If you decide to write to us you are kindly requested to do so as soon as possible and preferably no later than 11 November 2022.

Please note that it is possible that the Court hearing may take place remotely via a teleconferencing service. It is requested that if you intend on attending the Court hearing (whether in person or via your representative), you inform USAA LTD, USAA S.A. and/or USAA S.A. UK Branch (using the contact details set out below) as soon as possible and preferably before **11 November 2022**. This will enable USAA LTD, USAA S.A. and USAA S.A. and USAA S.A. UK Branch to provide any details necessary to attend the hearing if it is to be held remotely.

Subject to Court approval, it is expected that policies (and related liabilities) included in the Proposed Transfer will automatically transfer to USAA S.A. or USAA S.A. UK Branch on **31 December 2022**.

Any change to the date of the Court hearing or the date of the Proposed Transfer will be announced on our website (<u>www.usaa.com/brexit</u>).

The Independent Expert has assessed the impact of the Proposed Transfer and has concluded that it will not materially adversely affect any group of policyholders.

In addition, USAA LTD has consulted closely with its regulators, the FCA and the PRA and USAA S.A. (including USAA S.A. UK Branch) has consulted closely with the CAA in respect of the Proposed Transfer. The UK regulators are entitled to make their own representations to the Court and we expect them to do so.

What should you do?

Please carefully read the information we have provided alongside this letter. We have enclosed a booklet containing more information and background in relation to the Proposed Transfer, including:

- "Questions and Answers" about the Proposed Transfer;
- a summary of the legal document that sets out the terms of the Proposed Transfer (the **Scheme Document**);
- a summary of the Independent Expert's report; and
- a copy of a legal notice setting out details of the Court hearing for the Proposed Transfer.

How to make your views known

If you are comfortable with the Proposed Transfer and the information contained in and included with this letter, you do not need to take any further action. However, should you need any further information or if you have any questions or concerns about the Proposed Transfer or consider that you may be adversely affected or if you have any objections to the Proposed Transfer then please contact us as soon as possible and preferably no later than **11 November 2022**.
