## GOOD STUDENT DISCOUNT (GSD)

### SAVINGS TO YOU!

This form has been sent to you because of your request or because our records show that you have one or more young drivers on your Automobile policy who may be eligible for a good student discount. To qualify this person must be licensed to drive, meet at least one of the scholastic requirements given on the application and be currently a:

1. Full time student in a high school, college, university or vocational technical school;
2. At least 16 years old and under the age of 25.

### If YOU HAVE RECEIVED THIS DISCOUNT IN THE PAST...

Now is the time to re-apply. This discount is not automatically renewed. Recertification is required annually.

### TO RECEIVE THIS DISCOUNT NOW...

We need your electronic signature (e-signature) or a signed application or other proof, as outlined below, for each operator qualifying for GSD.

  - ◆ A transcript\*; or
  - ◆ Other proof of academic performance, such as a grade report, letter from the dean or similar scholastic achievement list\*; or
  - ◆ The application completed by a school official.
